**Exceptional creativity** which, for this purpose, shall mean the demonstration of unique or outstanding creative products and/or the demonstration of unusual problem solving ability or other learning characteristics which may indicate that the student has the intellectual potential to perform academically at a level significantly higher than the norm for the chronological grade level.



#### **Appeals Process:**

Advocacy for individual students is encouraged in eligibility, change in placement, and exit processes for the Highly Capable/Highly Motivated program. If parents/guardians disagree with decisions, they are welcome to appeal the decisions. The appeal of decisions must be made in writing by a parent/guardian, a teacher, student, or other appropriate school personnel to the building principal who will appoint and chair the building Appeals Committee. The Appeals Committee will include the District Superintendent and at least one representative of the Multi-Disciplinary Selection Committee. In addition to the appeal form, the appellant is requested to present additional objective assessment data for review. For transfer students, additional data may include recent school testing results from previous school district. If a current student, additional data may include assessment results from qualified sources outside the school district. Appeals should be submitted within 15 days of notice of the student's ineligibility for services. The Appeals Committee will review the appeal and make their final determination within 30 days of receipt of the appeal.
