# ADDENDUM #1 TO 2021 INTERLOCAL AGREEMENT BETWEEN THE SWINOMISH INDIAN TRIBAL COMMUNITY AND LA CONNER SCHOOL DISTRICT

THIS ADDENDUM is entered into by and between the Swinomish Indian Tribal Community, 11404 Moorage Way, La Conner, WA, 98257, a federally recognized Indian Tribe organized pursuant to section sixteen of the Indian Reorganization Act of 1934 ("Tribe"), and La Conner School District, PO Box 2103, La Conner, WA, 98257 ("LCSD").

## 1. Purpose and Effect of Addendum

This Addendum #1 amends the Interlocal Agreement entered into on March 22, 2021 between the Tribe and LCSD ("2021 Interlocal Agreement"). On January 4, 2022, pursuant to Senate Resolution No. 2022-01-003, the Swinomish Indian Senate authorized, appropriated, and approved contribution(s) in the amount specified herein to LCSD from Swinomish Use & Occupancy Tax revenue collected in 2022. In accordance with Paragraph 2.3 of the 2021 Interlocal Agreement, this Addendum #1 memorializes the Tribe's forthcoming 2022 contribution(s). Except for the specific contribution(s) and terms detailed herein, the terms and conditions of the 2021 Interlocal Agreement remain in full force and effect and are not altered in any fashion by this Addendum #1.

### 2. Use & Occupancy Tax Contributions

The Swinomish Senate approved 2022 contribution(s) totaling \$665,000.00 to LCSD in the following amounts and for the following purposes:

- a) \$500,000.00 [General Contribution unrestricted]
- b) \$100,000.00 [Roofing Repairs Payment 5 of 5]
- c) \$ 40,000.00 [Stadium Improvements visitor's bleachers replacement]
- d) \$ 25,000.00 [Science and Culinary Programs replace appliances and countertops]

# 3. Payout Schedule

The contribution amount(s) specified above will be paid pursuant to the formula detailed in Paragraphs 2.1.2 through 2.1.4 of the 2021 Interlocal Agreement, which is not altered or amended by this Addendum #1.

#### 4. Effective Date

This Addendum will become effective upon signature and execution by both Parties to the 2021 Interlocal Agreement.
