General Fund

The preparation of the General Fund budget for the 2021-22 school year was based on the following budget assumptions:

- 578.00 Total Funded FTE Students 555.00 K-12, 23.00 FTE Running Start (603.37 FTE actual for 2020-21).
- 8.00 FTE Funded CTE Students (4.52 FTE actual for 2020-21).
- 101.00 FTE Special Education Students (100.67 FTE actual for 2020-21).
- 31.80 FTE State funded Certificated Instructional BEA staffing.
- 10.38 FTE State funded Classified BEA staffing.
- 2.37 FTE State funded Certificated Administrative BEA staffing.
- Utilizing ESSER II Federal Grant Program 12 and ESSER III Federal Grant Program 13 to meet budgetary goals for 2021-22 school year.

General Fund Budget Goals:

- Maintain and/or expand existing school programs and services given the projected level of local, state and federal funding available for the 2021-22 school year.
- Increase the level of support within our budget devoted to textbook/instructional materials.
- Staff classrooms and provide supplies and materials to serve anticipated student enrollment projections by grade level while maintaining an ending fund balance of no less than 10% of projected expenditures for the 2021-22 school year.
- Budget for a \$200,000 transfer to the Capital Projects Fund for future approved building improvements.
- Budget for a \$31,250 transfer to the Debt Service Fund for final installment of "non-voted bond debt" due December 1, 2021.
- Ensure the District continues to qualify for annual Federal Impact Aid Grant funding for FY 2023 (FY 2022 was submitted in January, 2021)
- Account for all employee groups contractual bargaining agreement costs when approved by the Board of Directors.
- Account for all known utility, insurance, supplies and material requirements for the 2021-22 school year, including a projected inflation factor of 3%.
- Establish co-curricular/athletics budget for 2021-22 school year to support a full school year level of activities.
- Establish the 2021-22 food service budget to continue under our current format, serving all children at no cost to their families for breakfast and lunch during each instructional day.
- Utilize ESSER II & III Federal Grants to provide additional staffing over projected local & state funding levels in support of our student's transition back to classroom instruction and increased student achievement during the upcoming school year.
