AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of La Conner School District No. 311 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Payroll – leave cash outs
- Accounts payable – general disbursements including credit cards and travel reimbursements
- Tracking of inventory including technology shop items and computers
- Student enrollment reporting

INFORMATION ABOUT THE DISTRICT

La Conner School District No. 311 provides educational services to approximately 600 students in preschool through 12th grade in Skagit County. The District operates one high school, one middle school, one elementary school and one preschool.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its staff of 50 certificated and 52 classified employees. The District operated on a general fund budget of \$10 million and \$11.2 million during fiscal years 2017 and 2018, respectively.
